In summary, all of the thirty-six (36) ASPA Applications under the Competitive Selection Process (CSP) have been approved by the ERC, with thirty-four (34) ASPAs implemented. Meanwhile, two (2) ASPAs have yet to be implemented despite receipt of ERC approval, as NGCP is awaiting the final decision of the AS Providers for the ASPA implementation considering its filed Motions with the ERC.

- CIP II Power Corp. Dispatchable Reserve in Luzon which has a pending Motion for Reconsideration filed with the ERC requesting for the re-evaluation of the interim approved rates and Motion for the Termination of the ASPA.
- SPC Island Power Corporation Dispatchable Reserve & Black Start Service for Visayas which has a pending Motion for the Termination of the ASPA.
