I/We acknowledge that I/we, and the other Bidder's officers and representatives have rights as a data subjects in relation to the processing of my/our personal data, including the right to access, correct, withdraw and object to the processing, as well as the right to lodge a complaint before the National Privacy Commission for any violation of the same. I am also aware that we may seek assistance from NGCP's Data Privacy Officer (DPO) for any question or issue relative to the processing of my/our personal data in connection with the CSP. 6. I/We confirm that the personal data and sensitive personal data I/we have submitted as part of the processing contemplated herein is accurate, and I/we undertake to keep the same up to date when necessary for the declared, specified and legitimate purposes herein mentioned.
